2018 Italian Heritage Summer Festival – July 13th, 14th & 15th

Application Deadline ~ March 5, 2018

What is the Italian Heritage Summer Festival?

It's a celebration of Family, Food and Fun! One of the most significant and successful assimilations of the 20th century has been the unique food, music and gaiety of the Italian people in our everyday lives. The Columbus Lodge, Order Sons of Italy in America proudly embrace the heritage of our forefathers, and wish to preserve these traditions with authentic Italian dishes, entertainment and dance. Our marketplace booths feature cultural exhibits, gifts, wares and demonstrations designed to bring the warmth of Italy home to central Ohio.

For 2018 we expect to have approximately 30 food vendors and 40,000+ guests.

Who is eligible to apply?

Applicants must be a year-round and/or seasonal operation with proven festival operational experience. Applicants must have all necessary licenses and insurance. The owner takes full legal responsibility for participation and is the party for whom all transactions will be conducted.

How do I apply?

Fill out the application and make sure it is completed by March 5, 2018.

All vendors must send photos of their serving areas. No money needs to be sent at this time.

How are vendors selected?

All applications will be reviewed and decisions will be made on or before April 23. A waiting list will be created for vendors not accepted. These vendors may be added if space opens up or other vendors do not return payment by the deadline.

~ No vendor is guaranteed to be in the Festival ~
Vendors are given preference based on the following criteria:

- Have unique items not served by other vendors
- Have attractive serving areas
- Have a solid track record with a Festival or strong references
- Have reasonable pricing

All decisions of the committee will be final

Will I receive confirmation of my application?

You will receive an email with a copy of your application immediately after submitting. On or before April 23, you will receive an acceptance or decline email.



Timeline

- March 5 ... Applications must be submitted
- April 23 ... Acceptance, decline emails sent
- May 7 Down payment and contracts must be postmarked or posted online
- June 18 Final payment must be postmarked Certificate of Insurance due

What food items am I allowed to sell?

Only items included on the original application will be allowed to be sold on-site (unless the committee grants permission before the Festival). The committee reserves the right to choose which of the items listed on your application will be allowed to be sold. On the application, list most important items first.

What beverages am I allowed to sell?

Any items that are not:

- Alcoholic

What is required of vendors?

If accepted, all vendors will be required to meet all deadlines set above for materials and payments. In addition, all vendors will be required to agree to the Festival regulations.

Finally, ALL VENDORS must provide *Sons of Italy Columbus* proof of commercial general liability insurance on an "occurrence" basis with liability limits in the amounts of \$1,000,000.00 per occurrence covering personal injury, bodily injury and property damage; list as additional insured the *Sons of Italy Columbus & the City of Dublin*. Questions should be directed to Festival Chairman, Sostene Codispoti @ 614.582.7366. VENDOR is also responsible for obtaining Certificates of Insurance for any and all subcontractors hired by VENDOR. Additionally, VENDORS have an ongoing duty to notify *Sons of Italy Columbus* of any changes to its insurance coverage up to and through the end of the Italian Heritage Summer Festival.
